
BLUE SERVICED + BUILT SWIMMING POOLS -

PETER KENT WORKED AT VARIOUS TIMES FOR ME WHEN I OPENED TRULY <sup>BLUE</sup> POOL UNTIL I FIRED HIM IN 2002. PETER WAS THE TYPE OF WORKER WHO WOULD JUST SHOW UP TO WORK AND IF I HAD WORK I WOULD USE HIM.

SOMETIME DURING THE PERIOD THAT COVERED SEPT 2001 UNTIL MAY OF 2002 PETER KENT WAS ASSIGNED EITHER WITH CLINTON BEDOLL OR JAMES MOORE TO FIX A LEAK IN A POOL AT THE HOME OF THE SERABIANS LOCATED AT 33 SEASIDE DRIVE PT. JEFF. WHEN THEY RETURNED THAT DAY EITHER JAMES OR CLINTON INFORMED ME THAT <sup>THE</sup> POOL WAS STILL LEAKING BUT PETER WAS AT THE HOME BEFORE THE DATE OF THIS ASSIGNMENT. EITHER JAMES OR CLINTON TOLD ME THAT PETER KNEW THE LAYOUT OF THE PROPERTY. SINCE I KNEW PETER HAD WORKED FOR OTHER POOL COMPANIES I ASSUMED THAT HE WAS AT 33 SEASIDE DRIVE WITH ONE OF THE OTHER COMPANIES. IF THEY WENT INTO THE YARD AND ASKED PETER KENT TO COME INTO

the office so I could ask him about the pool. I asked Peter if he was ever at the house before + he answered with a question "Do you know whose house this is"? I said "No" And then Peter said that "it is the Tankleff house" I then say okay "have you been there before"? meaning pool work - Peter kept then said "Yeah I've been there" - I then said what did you do there? once again meaning the work that he did on the pool and he said "I had business there" then I said what did you do at the house - still meaning the pool and he answered "I HAD MY BUSINESS" I then walked away from him knowing that I was not going to get an answer AT that time I didn't connect him with the Tankleff murders. I connected him when I saw his name in an newspaper article with Glenn HARRIS - I fired Peter kept in 2002 when he fell asleep in the woods while working at the McCormick House - 123 N. Woods Drive Wadsworth River -


